

Employed Individuals with Disabilities (EID) Program Checklist

The EID program is a way for people with disabilities who are employed to BUY Medicaid (Medical Assistance) health insurance. Some people call this program the "Medicaid Buy In".

Should You Apply?

Are you at least 18 years old and not yet 65 years old?

Do you have a disability?

*As of March 2008, you are required to show that you get, or used to get, Social Security disability benefits; however, other types of proof of disability may become acceptable in the near future. Please contact one of the agencies on the back if you have any questions.

Are you currently employed?

-You could have a full-time or part-time job; or
-Be self-employed; for example, you run your own business, or baby-sit, mow lawns, or help others with chores for money.

Are you single with an income of \$5285 per month or less? *OR* Are you married with an income of \$7085 per month or less?

* The income limits above are for 2008. Many factors determine how income is counted. Your limit may be slightly higher or lower than those stated above. For more information, contact one of the resources on the back of this sheet.

Do you have under \$10,000 in countable assets (for example, checking and savings accounts, stocks, life insurance, second car)? Up to \$4000 in a retirement account does not count toward your \$10,000 limit.

If you checked all 5 boxes, you are probably eligible for the Employed Individuals with Disabilities Program. We recommend that you **call** the Maryland Department of Disabilities (MDOD) EID Project at **(800) 637-4113 (Voice/TTY)**. You will need to give your name, address, and phone number.

Staff will ask you questions and based on your answers, complete the application form. The form will be mailed to you for your signature. While you wait for the application to come in the mail, you should start collecting financial information to prove your income such as pay stubs, wage statements, W2s, or last year's tax forms.

When the application arrives, review the information, sign in the appropriate place and mail it to the address provided along with a \$75 check or money order which is the cost of 6 months of coverage. If you are determined NOT eligible for this program, the \$75 will be returned to you.
